**Secretarial Auditors' Certificate on implementation of Employees Stock Option Schemes in accordance with the provisions of Securities and Exchange Board of India (Share Based Employee Benefits and Sweat Equity) Regulations, 2021**

1. Securities and Exchange Board of India (Share Based Employee Benefits and Sweat Equity) Regulations, 2021 ('ESOP Regulations 2021') was notified effective from August 13, 2021 which repealed the Securities and Exchange Board of India (Share Based Employee Benefits) Regulations, 2014.
2. Jubilant Pharmova Limited ('the Company') has approached us, being Secretarial Auditors of the Company, to issue this certificate as required under Regulation 13 of ESOP Regulations, 2021 to be placed at the ensuing Annual General Meeting to be held for the financial year ended on March 31, 2023 that the Schemes have been implemented in accordance with the ESOP Regulations, 2021 and in accordance with the Resolutions of the Company.
4. The Company had approved the implementation of Employee Stock Benefits Scheme namely
  - i. 'JLL Employees Stock Option Plan 2018' by way of postal ballot dated August 6, 2018 and further made amendment by way of postal ballot dated November 14, 2022
  - ii. 'Jubilant General Employee Benefits Scheme 2019' at its Annual General Meeting held on September 25, 2019

(collectively referred to as the Schemes').

Based on our examination and the information and explanations given to us, we are of the opinion that the Schemes have been implemented, in all material respects, during the financial year ended March 31, 2023, in accordance with the ESOP Regulations, 2021 and the resolutions passed in the general meetings of the Company.

This certificate is addressed to and provided to the Board of Directors of the Company solely for the purpose of placing before the shareholders of the Company at the forthcoming Annual General Meeting pursuant to the requirements of the Regulations.
